

Literacy and 3rd Grade Retention Law

Welcome to our Third Grade Literacy Law Parent Communication page. In addition, this page will cover information that will help you better understand the 3rd-grade retention law recently passed by our Tennessee lawmakers and how it may affect your child, and parent resources to help your child at home. <u>3rd Grade Retention Law</u>

The Tennessee General Assembly has revised the state's law regarding the promotion of students from third grade, <u>T.C.A. § 49-6-3115</u>, and requires students who are determined to need additional supports in reading to receive them before being promoted to fourth grade.

What Parents Need to Know

The law (TCA 49-6-3115)(TCA 49-6-3115) requires that students who score in the bottom two achievement categories on the literacy component of the 3rd grade TCAP, our state's annual comprehensive assessment, receive certain supports or be retained in the third grade. Those supports are summer school and/or tutoring, intervention. To meet the expectations of this law, Jackson- Madison County Schools will be hosting a summer school for current third graders and will continue providing literacy tutoring offerings for students in the 2023-24 school year.



If a student does not receive a "met expectations" or "exceeds expectations" score on their ELA TCAP in third grade, elementary schools in Tennessee must provide multiple opportunities for intervention.

1. **Retake of the ELA section of the third grade TCAP:** This option is available for students who scored "approaching expectations" or "below expectations" on the ELA section of their third grade TCAP. The state will provide

a retake option over the summer prior to the student's fourth grade school year.

- 2. **Summer Bridge Camp:** This four-to-six-week summer camp would occur between the third and fourth grade school year. A student must attend 90% of summer lessons and make adequate growth on their post-test at the end of summer camp. This option is available for students who scored "approaching expectations" or "below expectations" on the ELA section of their third grade TCAP.
- 3. **High-dosage, low-ratio tutoring (TN ALL Corps or equivalent):** Fourth grade high-dosage, low-ratio tutoring that occurs twice a week for 30 minutes. This tutoring must occur for the duration of the fourth-grade school year and is available for students who scored "approaching expectations" or "below expectations."

Please note if a student scored "below expectations" on their ELA section of TCAP, the student must participate in multiple interventions including summer camp and high-dosage, low-ratio tutoring, if the parent and district elect a path <u>other</u> than retention.

Promotion Criteria for Students Identified for Retention

For students scoring **"below expectations"** on the TCAP, students identified for retention may be promoted if:

- The student is an English language learner and has received less than two years of ELA instruction,
- The student has a disability or suspected disability that impacts reading, OR
- The student was previously retained prior to their current third grade year.

Additionally, students scoring "below expectations" on the TCAP may be promoted if the following

interventions are provided:

- The student attends a learning loss bridge camp, maintains a 90% attendance rate at the camp, **AND**
- The student receives high-dosage, low-ratio tutoring using the TN ALL Corps grant or an equivalent high-dosage, low-ratio tutoring model for the entirety of fourth grade,
- The student may be promoted from fourth grade to fifth grade if the student demonstrates adequate growth on their fourth grade ELA TCAP. A student may only be retained in fourth grade one time.

For students scoring **"approaching expectations"** on their TCAP in ELA, students identified for retention may be promoted if:

- The student is an English language learner and has received less than two years of ELA instruction,
- The student has a disability or suspected disability that impacts reading, OR
- The student was previously retained prior to their current third grade year.

Additionally, students scoring "approaching expectations" may be promoted if the following interventions are provided:

- The student attends a summer learning camp, maintains a 90% attendance rate at the camp, and demonstrates adequate growth on the post-test, **OR**
- The student receives high-dosage, low-ratio tutoring using the TN ALL Corps grant or an equivalent high-dosage, low-ratio tutoring model (Tier III RT^{I2}) for the entirety of fourth grade.
 - If a student is promoted through high-dosage, low-ratio tutoring to the fourth grade, then the student may be promoted from fourth grade to fifth grade if the student demonstrates adequate growth on their fourth grade
 ELA TCAP. A student may only be retained in fourth grade one time.

Student Exemptions to 3rd Grade Retention Law

If your child scores "Approaching" or "Below" on the third grade ELA TNReady/TCAP, your child will **NOT** be retained if **ANY** of the following are true:

When will I know if this applies to my student?

Throughout the school year, parents will be informed of their child's progress as they prepare to take the TNReady/TCAP assessment. We will use our Aimsweb, universal reading screener in Fall, Winter and Spring, to communicate to parents of their student's current Reading progress and use these Aimsweb reports to identify if additional supports are needed to support your child's reading deficits and whether or not your student is likely to fall into the below or approaching categories on TNReady. We expect 3rd grade TNReady/TCAP scores to be returned to the district in late May. Your students' school will notify you with your student's 3rd grade scores immediately following their release, along with the options for summer school and/or tutoring.

Is My Student Eligible to Appeal a Retention Decision?

If the 3rd grade student received an "approaching" score on the TCAP ELA test, the parent or guardian may complete this appeal form to request the student's promotion to 4th grade.

Note: If the appeal is approved, then the student may be promoted to the next grade but would not necessarily receive any additional learning supports that may benefit them.

If the 3rd grade student received a "below" score on the TCAP ELA test or the summer retake, this form does not apply, and the student is not eligible for an appeal. In this case, your school will offer free summer school and/or tutoring supports to support your student in being able to move on to 4th grade.
